Included herein is additional information and clarification for the above referenced invitation to bid. Please consider all of the information when preparing your bid. Please acknowledge receipt of this addendum by signing in the space provided and returning it **with** your bid packet submittal.

- *Are substitutions of materials with similar specifications allowed?* **No, a product substitution of materials with similar specifications is not allowed.**
- *Is there a preference of brand cables?* **Yes, OFS brand of cable is required.**
- *What is the most relevant factor for award of bid?* **The responsive bidder with lowest grand total price, including shipping, will be awarded the bid. Please note: The Port of Lewiston is a tax exempt municipal corporation and sales tax is not applicable.**
- *Is there a bid plan-holder registration process?* **No. Please see "Bid Instructions -- Terms and Conditions" for submission of bid packets.**
- *Do companies need to be an approved supplier by the Port of Lewiston before a bid will be accepted?* **No.**
- *Is the physical address of 1626 6th Ave North also the ship-to address?* **No, this is the billing address for the Port's Administrative Offices and where the bid opening will occur. The delivery address for products will be the Port's warehouse at 1208 6th Ave North.**
- *F.O.B Clarification:* **Seller is responsible to deliver the cable reels to the Port's warehouse located at 1208 6th Ave North, Lewiston, Idaho 83501. Ownership and risk of loss transferring after the products are delivered to the Port of Lewiston warehouse. The Port will unload the reels.**
- *Is delivery of materials required all at once or as requested?* **Delivery of the entire order shall be delivered complete (all items) to reduce associated transportation costs to the Port. Any delivery to the Port of Lewiston must be Monday-Thursday between the hours of 8am-4pm PST.**

- *Is there a desired delivery date?* **No.** Information regarding 'maximum delivery dates' allows the Port to plan installation and construction based on the availability of materials. Phased construction is not planned. Receipt of the order, in its entirety, as soon as possible is desired.


